

# Louisiana School Readiness Tax Credit

## 2019 Contribution Form

Recent data from the Louisiana Department of Education indicates that 60% of all NWLA children enter kindergarten without the basic readiness skills they need, *starting behind on their very first day of school*. To address this need across the state, in 2007 the Louisiana Legislature passed a unique package of tax credits known as the **School Readiness Tax Credits**. For Louisiana businesses, there is a REFUNDABLE state tax credit for 100% of donations up to \$5,000 made to a Louisiana Child Care Resource and Referral agency (CCR&R.) The CCR&R for NWLA is the **NSU Child and Family Network**.

By encouraging the strategic use of School Readiness Tax Credit funds, the Step Forward Early Childhood Network Team and NWLA business community is working with NSU Child and Family Network to improve the school readiness of our youngest children. Funds will be used for the following priorities in Bossier, Caddo, DeSoto, and Webster parishes:

- 1) to provide parent training regarding early brain development and language development
- 2) to provide staff training regarding early brain development and language development for organizations serving young children
- 3) to purchase evidence-based curriculum and staff training to promote early language and math development
- 4) to purchase developmentally-appropriate materials to promote early language and math development
